 - i. Mike D.: Cal North allowing leagues to dictate requirements for coaching licenses; should U6 coaches take at least online module? and no first-year coaching waiver? **Vote deferred** to next meeting
 - ii. Jason: cost involved with any of the online modules (even 4x4), if you coach x2 or more teams should coach be required to take all pertinent modules? Should all F licenses be equated to an online module, even if the F license predated the online course (US Soccer will have no record of the F license if it predated their online requirement)?
