- Rule against “coaching” is a safety issue and hurts the flow of the game (e.g. kids standing around not knowing who is supposed to take a throw-in)
- Coaching during Players Day is assumed to be negative, when it can be positive and therefore shouldn't be limited
- League should focus on “excellence” in achievement from coaches and players, and Players Day inhibits the pursuit of top quality coaching and on-field performance from players
